Purpose of the Policy

The purpose of this policy is to establish the criteria for coverage of Cerezyme.

Statement of the Policy

Health Alliance Medical Plans and Health Alliance Northwest will approve the use of Cerezyme under the Specialty Medical benefit when the following criteria have been met.

Criteria

- 1. Coverage Criteria for the Treatment of Gaucher Disease**
 - 1.1 Diagnosis of type 1 Gaucher disease with one of the following
 - Anemia (low level of red blood cells or hemoglobin)
 - Bone disease
 - Hepatomegaly (enlarged liver)
 - Splenomegaly (enlarged spleen)
 - Thrombocytopenia (low level of platelets in the blood)
 - 1.2 Prescribed by a Geneticist (gene doctor)
 - 1.3 Age 2 years or older
- 2. Exclusion Criteria**
 - 2.1 Not used in combination with Elelyso, Cerdelga, VPRIV, or Zavesca
- 3. Approval Period**
 - 3.1 Initial: 12 months
 - 3.2 Reauthorization: 12 months with documented benefit from therapy
